An Act to amend the Constitution. 5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend the Constitution:

Be it enacted by the Oireachtas as follows:

Amendment of the Constitution 10

1. The Constitution is hereby amended as follows:

(a) the Article, the text of which is set out in *Part 1* of the Schedule, shall be inserted after Article 43 of the Irish text; and

(b) the Article, the text of which is set out in *Part 2* of the Schedule, shall be inserted after Article 43 of the English text. 15

Citation

2. (1) The amendment of the Constitution effected by this Act shall be called the Thirty-ninth Amendment of the Constitution.

(2) This Act may be cited as the Thirty-ninth Amendment of the Constitution (Right to a Home) Act 2020. 20
