Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act, “Principal Act” means the Health Act 2004.

Requirement of the HSE to include plans to improve services for people with Dual Diagnosis in the Annual Service Plan 10

2. The Principal Act is amended—

(a) in section 2 by the insertion of the following definition:

“ ‘Dual Diagnosis’ means the term used when a person experiences both a substance abuse problem and a mental health issue such as depression or an anxiety disorder. Treatment options must address both;”, 15

and

(b) in section 31(4) by the substitution of the following paragraph for paragraph (a):

“(a) indicate the type and volume of health and personal social services to be provided by the Executive during the period to which the plan relates and shall, in the promotion of a comprehensive health service, specifically include plans to secure improvements in services for people with Dual Diagnosis and provide for the continuum of care for those that present to a mental health service, addiction service or any other health service with Dual Diagnosis.”. 20 25

Short title and commencement

3. (1) This Act may be referred to as the Health (Dual Diagnosis: No Wrong Door) Act 2021

(2) This Act shall come into effect on such day as may be appointed by the Minister for Health. 30
